Through this service the taxpayer can request an appointment to receive telephone attention by a specialist

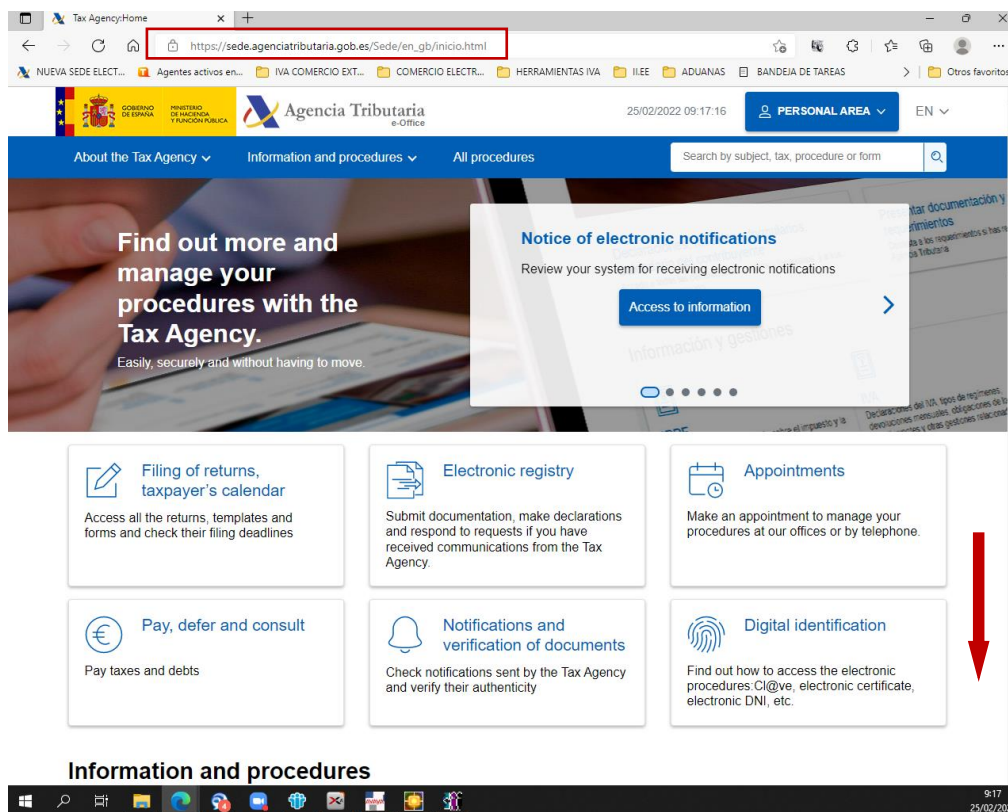
CHANNEL 2: RECEIVE IMMEDIATE CALL ("Click to Call")
